COMPLETION OF MEMBERSHIP APPLICATION FORMS

- 1. The proposer and seconder are responsible for the applicant's eligibility in accordance with Club Rule 4.
- 2. Both proposer and seconder are to be full Club Members of not less than 2 years and 1 years standing respectively. Neither the proposer nor the seconder is to have proposed or seconded more than two applicants within the 12-month period commencing 1st March.
- 3. To be eligible for playing membership, all applicants are to possess an official golf Handicap. Applicants who do not possess current handicaps may alternatively submit three cards.
- 4. This application form, when completed, is to be forwarded to the Club Manager together with:
 - a. A letter of introduction from the applicant outlining your golfing background.
 - b. A letter of introduction from the proposer outlining how long they have known the applicant and his/her ability as a golfer if applicable.
 - c. A current golf handicap certificate if applicable, or a letter of introduction from the applicant's current/most recent Golf Club.
- 5. All membership applications will be acknowledged and interviews will be arranged at the earliest opportunity.
